

## **ACA Newsletter – Education Europe. (hereafter referred to as “ACA NL”)**

### **General terms and conditions**

#### **General points**

1. Any subscription contract entered with ACA NL or any renewed subscription infers full acceptance on the part of the subscriber of all present general terms and conditions. Only the specific terms or conditions of a special contract concluded between ACA NL and the subscriber may prevail over the present general conditions.
2. Any dispute regarding the validity, interpretation or execution of the contract will be referred before the appropriate court in Brussels, including summary procedures and cases involving more than one defendant. Only Belgian law is applicable.

#### **Subscriptions, fees, payment mode and cancellation**

3. The subscription period is 12 months.
4. Subscriptions always begin on the day of submission of the online subscription form.
5. Unless the subscriber submits his cancellation of the subscription in writing (emails and faxes are accepted) within 45 days upon submission of the subscription form, the subscription will be valid for a period of 12 months.
6. All subscriptions not cancelled in writing (e-mail and faxes are accepted) a month prior to their expiring will be automatically extended at the applicable rate on the renewal deadline. No refunds are available in cases of cancellation of ongoing subscriptions
7. The price of a 12-month subscription is EUR 120. Subscribers of ACA NL receive a discount of EUR 20 for the attendance of ACA European Policy Seminars and EUR 50 for the attendance of the ACA Annual Conferences.
8. The individual discounts for ACA European Policy Seminars and the ACA Annual Conferences are not transferable.
9. Unless mentioned otherwise, all our prices are indicated in Euros.
10. ACA NL invoices are payable in full and net of transaction fees, which remain charged to the subscriber. The subscriber alone is responsible for effective payment, with payment deemed to have been made only once ACA NL accounts are credited with the sum due. If a payment is delayed, the subscription can be suspended without prior notice. It will be resumed again upon receipt of the total amount.
11. The delayed payment of invoices will leave the subscriber liable without prior notice to late payment interest charges at an annual rate of 10%.

### **Limitation of liability**

12. ACA NL strives to provide exhaustive and verified information. However, ACA NL declines all responsibility in case of damage to the subscriber or any other corporate body or individual stemming from the exploitation of erroneous information or the absence of an information item.

13. Should ACA NL not be able, by *force majeure*, to publish a monthly issue, its liability is limited to replacing the issue which has been interrupted by an alternative issue.

14. ACA NL reserves the right in its sole discretion to effect any amendment or alteration to the content and information, including pricing and rates, set out in this website.

### **Protection of privacy**

15. Information concerning subscribers is held on ACA NL files in accordance with Belgian law. Subscribers can request access to this information at any time and demand that any inaccuracies be corrected. This information will under no circumstances be passed on to third parties.
